VII. Old Business

a. Sexual Misconduct Resolution

Chair Mir: last fall the diversity committee was charged with drafting up a zero tolerance policy for sexual assault. After talking to many we have decided that a zero tolerance policy is not the best policy. We are now presenting this resolution that encourages a change to be made regarding the changing of suspension to expulsion for non consensual sexual intercourse. This is the one I think we can all agree on that we care about the most.

Co-President Ngabirano: Questions

Wicklund: when someone is suspended or expelled are they trespassed?

JoNes: yes for both but, they are prohibited from campus for the duration of their suspension. Expulsion means there are always

prohibited from campus. During ones suspension they can come to campus if it is really needed and if a professor signs off along with the dean of students than they can visit but the complainant will be notified of where the person will be and the time.

Co-President Svendsen: do you think students want this?
Patty: it is not widely accepted. Many time victims want to decide what happens, and having only one option can take away some control from the victims. I cannot find an institution that only has the one option

Wicklund: can we make it where it's explosion unless the victim wants it to be a lesser sentence.

JoNes: it is the sanctioning bodies decision on the punishment and not the victims

Wicklund: would they take into account what the survivor says Patty: we start at expulsion and work backwards and they will definitely take into account the victims statement.

O'Neil: is the board trained differently?

Patty: they are trauma trained and the investigation process is very different. Having one sanction can be very challenging. Co-President Ngabirano: Questions - none. Discussion Wicklund: title IX sanctions are supposed to be educational. The thought behind this is that suspending someone does not require them to received help so they will come back not any better, so that was our thought process for supporting just explosion.

Schugel: I serve on sexual misconduct board. The cases are always more complex and I disagree with this resolution. I trust Patty's advice.

JoNes: sometimes we have added educational pieces to a suspension, and could be placed on probation for when they return to campus they need to get more education. The board can suspend and implement other sanctions as well.

Tengesdal: I oppose this, cases are very complex. And we need to have survivors interests in mind

Wicklund: can they return without having educational or can we mandate that they need an educational before they can return Patty: it is possible that they could be allowed back on campus without an educational, but I don't believe it has ever happened.

Wicklund: I think we should send this back to diversity committee to add the educational component

Chair: Mir: I advocate for changing directions here and bringing it back to re-evaluate.

Allen: I support sending this back to diversity committee.

Co-President Svendsen: Thank you Patty for being here and answering our questions, our goal is to create something that helps survivors in this situation. We want to help survivors feel like they have a voice and are safe. So thank you for being here Co-President Ngabirano: Discussion
