a. FCA

IV. Community Comment

a. Tobacco Free Initiative

TFI: We are working with a \$15,000 grant from the American Cancer Society. According to a study of GAC students 68% of students have experienced second-hand smoke. The 2007 freedom to breathe act of minnesota made those who experience second-hand smoke a protected class. Our main goals are to make people aware of where they can smoke on campus not tell people they can't smoke.

Co-President Svendsen: Questions?

Wicklund: Where would people be able to smoke on campus if your not going to tell people not to smoke.

TFI: We would have not designated smoking area on campus currently. We have found that if we set on place it is common for protesters to gather and shame those who smoke. It would also cost money to create a specific shelter outside.

TFI: As we have written the language now, it would function as a ban.

Allen: What are you using the grant money for.

TFI: We are mostly focused on awareness right now.

Ombudsperson O'neil: If we take this photo how would it be used.

TFI: It would go on our Facebook and Instagram

Chair Mir: What other groups have you worked with.

TFI: Athletic teams, professors, health services, and the PA's.

Co-President Svendsen: The purpose of TFI coming in today was to ask us to take a photo for them. We wanted to open the floor for discussion because we represent the student body not only ourselves.

Co-President Svendsen: I open the floor to discussion? Wicklund: If we are going to do this we should ask our constituents what they think of this issue.
