Committee Updates

A. Parliamentarian Parli Pro Review

- a. Parliamentarian Davison discusses the importance of speaking clearly and concisely as well as the purpose of using the point of information.

B. Resignation of Senator Chochran

Old Business

A. Rundstrom Lights and Sidewalks

C. Slingshot Concerns (Student and Faculty)

- a. There is on-going concern over the use of slingshot in the student body and moving into J-Term the senate will continue to investigate this.
- b. Senator Antinoro motions to charge Student and Academic affairs with the investigation of slingshot. Chair Maurer seconds the motion. There is no more discussion on the motion. The motion passes.

New Business

A. International Student Support

- a. There is discussion about the Russia/Ukraine conflict and concern over flags being removed from the entryway of the International Center. There is also concern about lack of support over international conflicts in students' countries of origin. Chair Hathy motions to charge the Student and Academic affairs committee and the Inclusive Excellence committee. Senator Guckhool seconds this motion.
- b. There is discussion about this matter. There are other schools attempting to implement similar things in schools around Minnesota. There is also further discussion about attempts by Residential Life to remedy the situation.
- c. The inclusive excellence committee asks that if other members of the senate hear anything else about issues that international students have they should reach out.
- d. The charge passes.

B. Recognized Student Organizations Update

- a. Controller Thompson asks if there is any update on the recognition of student organizations from Eta Sigma Phi or Gustavus Ambassadors specifically.
- b. There is discussion about reaching out to Izzy Lind or Ann Volk about whether or not Gustavus Ambassadors is recognized.
- c. There is discussion about reaching out to Co-President Nelson about whether or not Eta Sigma Phi has been recognized yet.
